COLON CANCER CHECK: FIT LAUNCH UPDATE >

Ontario is transitioning from the guaic fecal occult blood test (gFOBT) to the fecal immunochemical test (FIT) for people at average risk of colorectal cancer on June 24, 2019. FIT is an at-home stool-based test that is more sensitive for the detection of colorectal cancer and unlike gFOBT, also detects pre-cancerous polyps. It is easier to use, with one sample required and no dietary or medication restrictions.



HOW TO SCREEN WITH FIT - A STEP BY STEP GUIDE FOR PROVIDERS AND PATIENTS

Steps for Primary Care Providers

- 1. Confirm mailing address for FIT kit, patient address + date of birth
- 2. Explain to patient how to complete the FIT test
- 3. Submit completed FIT requisition to LifeLabs directly through your EMR or by faxing 1-833-676-1427

LifeLabs will mail prelabelled FIT kit to patient.



Steps for Patients

- 1. Check label accuracy and clearly record specimen ("poop")
- collection date on FIT tube (DD/MM/YYYY)
- 2. Collect stool sample
- 3. Mail or drop off FIT to LifeLabs as soon as possible, ideally within 2 days of sample collection, to ensure it arrives at the lab with 14 days

LifeLabs will send FIT result to Primary Care Provider. Cancer Care Ontario will mail FIT result letter to patient.

Follow-up by Primary Care Providers

- Normal FIT result: Repeat FIT in 2 years
- Abnormal FIT result: Refer within 2 weeks for follow-up colonoscopy to be performed within 8 weeks

- Only use the new FIT requisition. Do not use OHIP requisitions or submit them to other labs.
- You can indicate on the FIT requisition whether the FIT kit should be mailed to an alternate address, which may differ from the patient's primary mailing address (e.g. health centre or nursing station, community health centres, etc.)
- To prevent mailing errors and delays, double check patient address information, such as unit number and postal code.
- Patients can drop off their FIT at any LifeLabs Patient Service Centre duing business hours. For locations and hours, visit locations.LifeLabs.com

BARRIERS TO FOLLOW-UP AFTER AN ABNORMAL FOBT RESULT

The American Journal of Gastroenterology has recently published a study of barriers to follow-up colonoscopy after an abnormal colorectal cancer screening FOBT result. The study was led by Cancer Care Ontario scientists Dr. Jill Tinmouth and Dr. Diego Llovet, with funding from the Ontario Institute for Cancer Research. Investigators conducted qualitative interviews with 30 colorectal cancer screening participants in Ontario who did not have a followup colonoscopy after an abnormal FOBT result, and 30 primary care providers with at least one patient in this situation. This is the first study to interview persons with abnormal FOBT results to understand the reasons for a lack of follow-up colonoscopy.

Reasons for a lack of follow-up colonoscopy:

- Person and/or provider believed FOBT+ was a false positive
- Person experienced fear, anxiety, or uneasiness about colonoscopy
- Breakdown in communication of FOBT+ or of colonoscopy appointments
- Person had other health issues causing delay or refusal of colonoscopy

Study Conclusions

According to the abstract, "PCPs may not adequately counsel FOBT+ persons who believe the FOBT+ is a false positive and/or fear colonoscopy. PCPs may lack fail-safe systems to communicate FOBT+ results and colonoscopy appointments. Using navigators may help address these barriers and increase follow-up rates."

PHYSICIAN REGISTRATION FOR PATIENT ATTACHMENT

As part of the

ColonCancerCheck program, unattached patients (those without a primary care provider) are able to be screened.



Patients with an abnormal FIT result require an urgent colonoscopy. Please consider registering to accept unattached patients requiring this follow-up to your practice.

If you are a patient enrolment model (PEM) physician and you roster patients referred from CCO to your practice, you can claim the Q043A New Patient Fee FOBT Positive/Colorectal Cancer (CRC) Increased Risk.

MARCH 2019 - RECOMMENDATIONS FOR POST-POLYPECTOMY SURVEILLANCE

Cancer Care Ontario has released the ColonCancerCheck's (CCC) Recommendations for Post-Polypectomy Surveillance, as well as a supporting tool.

The recommendations were developed under the guidance of a panel of experts in gastroenterology, pathology and colorectal surgery who analyzed evidence from a literature review of post-polypectomy surveillance guidelines, as well as a systematic review and metaanalysis on the risks associated with low risk adenomas. The recommendations were reviewed by national and international experts and their feedback has been incorporated.

Compared to the 2006 U.S. Multi-Society Task Force on Colorectal Cancer post-polypectomy surveillance guidelines adopted by CCC in 2008, the updated recommendations include guidance based on findings made at both the initial and subsequent colonoscopy. The recommendations clarify that people with no polyps or hyperplastic polyps in the rectum or sigmoid, as well as people with low risk adenomas, should rescreen with the fecal immunochemical test (FIT) and not undergo surveillance colonoscopy. My patient has a low risk adenoma. What would the next steps be?



SCREENING ACTIVITY REPORT

The Screening Activity Report (SAR) is a supplementary electronic tool available to all patient enrolment model primary care physicians to support improving cancer screening rates and appropriate follow-up for the breast, cervical, and colorectal cancer screening programs. The interactive platform allows physicians to quickly find specific cancer screening information for each patient.

A recent partnership with eHealth Ontario and the CPSO has simplified the ONE ID registration process. You no longer need to provide identity documents to an eHealth Ontario Legal Registration Authority (LRA), you are able to self-register for ONE ID.

ONE ID and SAR Registration for CPSO Members

- On the CPSO website: log in using your CPSO account credentials and click on "Get your eHealth ONE ID" on the "Welcome" page.
- Review and agree to the Consent Statement and then click on the "Register for ONE ID" button.
- You will be directed to the ONE ID site to complete the registration. Once completed, you will be provided with a login ID (FIRSTNAME.LASTNAME@ONEID.ON.CA).
- Once registered for ONE ID, contact our Prevention and Screening team LRA, Sarah Blyth at sblyth@southlakeregional.org and provide your name, CPSO number and ONE ID login to gain access to your SAR.
